Bidders shall have the option to submit their bid electronically also*
- 5) Bids must be submitted to the office of Madhuban Municipality Office, Bardiya on or before 12:00 hour **2074/11/22**. Bid Documents after this deadline shall not be accepted.
- 6) Bids shall be opened in the presence of Bidders' representatives chosen by Bidders to attend at 14:00 hour and **2074/11/22** at the office of Madhuban Municipality, Bardiya.
- 7) Bids must be valid for a period of 90 days after bid opening and must be accompanied by bid security, amounting as specified for each item in the following table, which shall be valid for 30 days beyond the bid validity period.
- 8) If bidder wishes to submit the Bid Security in the form of cash, the cash should be deposited in Deposit Office Account No. **4140303007103** at *Rastriya Banijya Bank, Gulariya Branch* and submit the receipt of the deposited amount of cash along with the bid document and Office Account no : **4140304018103** (for bid document cost).
- 9) If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered as the last day.
- 10) Bidders are advised to visit site and assess the actual site conditions before submitting their bids.
